A. PUBLIC HEARING TO REVIEW THE 2025/2026 ADOPTED BUDGET

Governing Board Jill Broussard called the Public Hearing to order at 3:00 p.m. Via zoom. Those in attendance were Jill Broussard, Pinal County School Superintendent; Ector Rodriguez, Mary C. O'Brien Superintendent; Tonya Taylor, Chief Deputy; Sherree Ramirez, Business Manager and Michelle Gonzalez, Board Secretary in attendance.

Key highlights included:

M&O funding will increase by 3.0%, or \$80,407, over FY2025 (refer to Page 1).

Fund 610 will decrease by 4.4%, or \$77,290, from FY2025 to FY2026 (refer to Page 4).

The budgeted carryover is \$587,919 (refer to Summary Page 1).

A summary of the adopted budget and the public notice of hearing for the 2025–2026 fiscal year will be posted on the district website and the Arizona Department of Education's budget system.
